1. **Object of the contract:** „Procurement of road sweepers for Glina Local Sanitation Service”.
2. **Means through which the addendum is awarded:** offline direct award
3. **Financing source of the services contract to be awarded:**
 - o Glina local sanitation service budget for 2021.
4. **Maximum assigned budget:** maximum 135.000,00 lei net of VAT.
5. **Term of the contract:** The supply of road sweepers will be made in maximum 15 business days after signing the contract
6. **The tender submitted by the tenderer must include the following:**
 - a) **Technical proposal:** The technical proposal will be prepared and presented in Romanian language. The technical proposal must include the presentation of the technical specification sheet of the sweeper, which must demonstrate the fulfilment of all technical conditions that are imposed.
 - b) **Financial proposal (tender form).**
 7. **The validity period of the tenders:** 30 days
 8. **The tender price** will be expressed in **RON net of VAT.**
 9. **The tender price is fixed in RON (LEI), equivalent to maximum 27.000 euro at the exchange rate valid for the day.**

The update of the contractual price will not be accepted.

10. **Along with the basic tender:** **NO** alternative tenders will be accepted; the technical specification sheet of the sweeper must prove the integral fulfilment of all technical specifications that are provided.
11. **The tender will be accompanied by the following documents:**
 - Expression of interest
 - Power of attorney
12. **Award criteria:** Lowest price
13. **Performance bond:** **NO performance bond will be constituted**, according to the provisions of art. 39 paragraph (2) of the Governmental Decision no. 395/2016. The warranty for the utility vehicle is different/ distinct from the performance bond.
